The revised financial estimates for the year 2002-2003 were placed before the Finance Committee The revision was necessitated mainly because of upward revision of stipend/assistantship by UGC/CSIR and land acquisition by TERI on behalf of the School.

Shri V.K. Pipersenia, Joint Secretary and Financial Adviser, Government of India, advised that the acquired land and property be registered in the name of TERI School as recommended in guidelines of UGC so that TERI does not have to pay additional registration charges for transferring land to TERI School.

The Revised Financial Estimates were recommended by the Finance Committee to the Board of Management for approval.

#### <u>Item No. 5</u>: To scrutinise the Financial Estimates for the Financial Year 2003-2004

Action Finance Officer/ The Financial Estimates for the Financial Year 2003-2004 were placed before the Committee and were duly scrutinised.

Shri V K Pipersenia, Joint Secretary & Financial Adviser, Government of India, suggested that as far as possible candidates who have qualified the UGC/CSIR NET examination should be taken for the Ph.D. programmes to reduce the costs to the School.

With respect to fee structure for M.Sc. courses, he advised that the fee structure should strike a balance between the costs of conducting a course and quality of students admitted to the programmes in the School. He further suggested that feasibility of securing bank loans by students for paying their fees should also be explored.

The proposed estimates for the Financial Year 2003-2004 were recommended by the Finance Committee to the Board of Management for approval.

There being no other item for discussion, the meeting ended with a vote of thanks to the Chair.
