MINUTES OF THE FORTY FIFTH MEETING OF THE BOARD OF MANAGEMENT

Leave of absence: Dr Sachin Chaturvedi, Dr V P Singh and Mr O.P. Agarwal could not attend the meeting.

The Chairperson welcomed Dr Swati Basu and Prof Nitya Nanda who joined the Board meeting for the first time. He also welcomed Prof Basabi Bhaumik in her capacity as the Chancellor's nominee. He also welcomed Mr O.P. Agarwal who could not attend the meeting. He introduced the new members by sharing their brief bio-profile and hoped that the TERI School of Advanced Studies would be benefitted by their huge experience and wisdom through this association. He also welcomed Dr Sukanya Das, Associate Professor, TERI SAS, who was joining this meeting for the first time.

Item No. 1: To confirm the minutes of the Forty Fourth meeting of the Board of Management held on 02 September 2022

The Registrar informed that the minutes of the Forty Fourth meeting of the Board of Management held on 02 September 2022 were circulated to the members of the Board and comments received were incorporated and recirculated to the members. The Board may, consider confirming the minutes.

TS/BM/45.1.1. The Board resolved that the minutes of the 44th meeting of the Board of Management held on 02 September 2022 be confirmed.

Item No. 2: NEP implementation.

The Registrar requested the Dean (Academic) to make the presentation on NEP implementation. Dean (A) made a small presentation on the status of NEP 2020 implementation at TERI SAS as attached in **Enclosure 1**. He informed the Board that TERI SAS is already practicing some of the features mentioned in NEP 2020. Prof Bhaumik suggested conduct of online courses which could attract large audience and revenue. In response Dean (A) informed that we are offering single course for long time but enrolment has not been encouraging it is in single digit. He further stated we should pick up some course which attracts larger audience. Dr Swati Basu stated conduct of some training course to industry people that would also be a good source of revenue.

Board noted the matter and appreciated the efforts being taken in this direction.

Item No. 3: Establishment of Research Development Cell.

Before the agenda item was taken up Prof Prateek Sharma informed the Board that under Scientific and Industrial Research Organizations (SIRO), research Centres are created to focus primarily on research activities. However, due to pandemic, nothing much happened in the last two years. In the previous Board meeting, the Board was informed about the setting up of Emerson Centre of Excellence for Sustainability Studies and the IPCA Centre for Waste Management and Research. The Board was informed about receipt of funds from the two organisations. It was informed that efforts are being made to create more such Centres. These Centres will concentre to create knowledge in the thematic areas for which they have been established. The process is to gradually increase the activities of the Centres to conduct short term training programmes, capacity building programmes for working professionals and conducting workshops, seminar for disseminating knowledge.

In order to streamline the research activities, a Research Development Cell (RDC) was set up as per the UGC guidelines. The Chairperson then requested the Registrar to take up the agenda item. The Registrar requested the Dean (Research & Partnership) to apprise the Board on the efforts made in the establishment of Research Development Cell. Prof. Shaleen Singhal, Dean (R&P), explained to the Board the constitution, objectives, etc. of the RDC, as enclosed at **Enclosure 2**.

Dr Swati Basu suggested that the R&D Centre, Research Advisory Committee and Research Development Cell should be integrated and work closely for better coordination. Board members also stated that some guidelines should be defined and come up with various indicators. Dr Vibha Dhawan also informed that since they have an HR expert her advice can be obtained on what are the best indicators and develop something which is best suited for the University.

The suggestions of the Board were noted.

Item No. 4: To approve Policy on Revenue sharing.

The Registrar informed that in the 38 Board of Management Meeting the Board recommended to present the revised revenue sharing document after

incorporating the comments and suggestions made by the members. He further requested Prof Prateek Sharma to elaborate on the point. Prof Prateek Sharma stated that when in the 38 Board meeting the point was put up, the then Acting Vice Chancellor, Prof Manipadma Datta had reservations on two point viz. ratio of sharing and the overhead charges. Prof. Sharma informed that he had discussed the issue internally and the same draft is put up and he requested the members to provide their inputs. After detailed deliberation on the subject, Prof Prateek Sharma thanked the Board members for their valuable input. He informed that the comments/suggestions of the Board would be incorporated in the Consultancy Policy and will be circulated to the Board for their approval.

Item No. 6: Establishment of a Centre for Youth Empowerment and Global Citizenship.

The Registrar requested Prof Prateek Sharma to brief the Board on the point. Prof Sharma informed that in order to involve the youth to participate in achieving the various Sustainable Development Goals a Centre for Youth Empowerment and Global Citizenship is being proposed to be set up in the TERI SAS. The proposed Centre will prioritize activities that will strengthen youth mobilisation and youth empowerment along with dissemination of environmental awareness amongst the youth. The Centre will involve the students in disseminating information related to sustainability goals amongst school and college students and achieving various sustainable development goals. Dr Livleen Kahlon in TERI who is part of environmental education area will assist and shall be taken as Adjunct Faculty to take the activities of the Centre forward. In order to establish the Centre efforts shall be made to raise the funds from Corporate houses. The intent of presenting the idea of the Centre was to take the view of the Board and seek principal approval so that detailed roadmap along with a more appropriate title for the Centre can be prepared in case the Board considers the idea worth pursuing. The Board members while in principle approving the establishment of the Centre for Youth Empowerment and Global Citizenship requested the Chairperson to make a detailed presentation on the activities of the Centre. (a) MoUs signed

(i) MoU between Thinkthrough Consulting Pvt. Ltd, New Delhi and TERI SAS was signed on 06 October 2022.

(TTC) is a purpose-led multidisciplinary professional services firm that specializes in providing advisory support to sustainable development initiatives, including social development and ESG. The purpose of this collaboration is to co-create and execute courses such as short-term certificate programmes and Faculty Development Programmes (FDP), Management Development Programmes (MDPs), Enrichment Programmes (FEPs), Faculty Corporate Meet (FCM), undertake capacity development and knowledge initiatives on topics related to Sustainability, Climate Change, Environment, Social, & Governance (ESG), Circular economy, Corporate Responsibility (CSR), GHG accounting services, carbon markets, energy transitions, nature based solutions (NBS) and other Sustainable Development Initiatives and areas.

Both the institutes aim at

- Exploring business opportunities in India or any other country—with prospective clients (Corporates, & Foundations, Intl. Financial Institutions, Global Multilateral and Bilateral Agencies and institutions, Government (both Central and state), Not-for-Profit Organizations, Regulatory Bodies, etc.), for establishing connect and relationship for possible pitching with solutions in the domain of Sustainability, Climate Change, Environment, Social & Governance (ESG), Circular economy, Corporate Social Responsibility (CSR), GHG accounting services, carbon markets, energy transitions, nature based solutions (NBS) and other related Sustainable Development Initiatives.
- Exchanging insights about client, regional context, and/or subject matter expertise/inputs that would help developing effective joint pitch document or proposal.
- Identifying local/global collaborator and/or professional/expert, if required, for some pursuits.
- Exploring the setting up of a center of excellence around sustainability focusing on the abovementioned thematic areas
- Carrying out any other matter as the Parties mutually decide for achieving the objective of the MoU.

(ii) MoU between Indian Pollution Control Association and TERI School of Advanced Studies was signed on 14 October 2022.

Indian Pollution Control Association (IPCA) is a not-for-profit organization conceived in 2001 by a group of environmentally conscious individuals who firmly believed at promoting environmentally sustainable practices at individual, community, institutional and industrial level. IPCA is registered under the Society Registration Act, XXI of 1860 and also registered under 80G and 12A act of Income Tax. IPCA is an ISO 9001:2015, ISO

14001:2015 & ISO 45001:2018 certified organization and pioneer in preparing and executing EPR Action Plan for Plastic Waste Management (PWM). IPCA has rich experience in formulating and executing community engagement program as well as developing infrastructure for effective management of waste and air.

IPCA is authorized Plastic Waste Recycler by CPCB and authorized PRO by Chandigarh Pollution Control Committee. IPCA is also expert committee member in the committee constituted by MoEFCC, CPCB, Govt of NCT of Delhi, Govt. of J&K, Govt. of Uttarakhand, and Municipal Corporation of Delhi.

IPCA has started its journey with door-to-door collection of municipal waste followed by segregation and composting. In the journey of over two decades, IPCA has worked extensively with various stakeholders including waste workers, waste generators and policy makers to develop sustainable supply chain of waste material. IPCA is also working on the project of Air Quality Monitoring and its management, Environmental Education and Awareness, improving life style of waste workers.

Adhering to the 15 out of 17 Sustainable Development Goals (SDGs) of UN, IPCA has created a network of more than 30,000 waste workers across 35 States and UTs of India and partnered with academic institutions like TERI SAS, Skill Council of Green Job (SCGJ) to encourage entrepreneurship in solid waste management. IPCA has also established Centre for Excellence in Waste Management & Research in collaboration with TERI SAS.

Implementation of the National Education Policy, 2020 (NEP 2020) at the TERI School of Advanced Studies

The National Education Policy framework of 2020 formulated by the Ministry of Human Resources Development, Government of India has strongly advocated, among other things, multi-disciplinary and research-oriented education that (a) provides a wide range of subject choices for students (c) removes or minimizes administrative and disciplinary barriers to the movement of students between different fields of study (c) enables life-long learning (d) places due emphasis on environmental and social issues impacting human societies worldwide (e) promotes inclusivity and (f) internationalizes education to orient students as global citizens.

It is heartening to note that TERI SAS, by virtue of its long-term and single-minded focus on the theme of sustainable development had effectively anticipated these trends, and has always fostered an atmosphere of open inquiry across disciplines and provided students with every opportunity to explore ideas across disciplinary and departmental boundaries. Additionally, TERI SAS staff have collaborated with TERI researchers over the long term, providing students with unique opportunities for training and research that are unavailable in traditional universities. As an entirely post-graduate institution, TERI SAS has always emphasized research-led teaching & learning as well as problem-solving. Very early on, its faculty members adopted a student-centric approach in programme formulation by facilitating course choices, both within and across programmes. The long-standing subscription of TERI SAS to the Developing Libraries Network (DELNET) has greatly facilitated access to journal publications and books and greatly mitigated physical and financial limitations.

Some of the most notable recent initiatives in further implementing the recommendations of NEP 2020 are a system of open electives, registration in the nationwide Academic Bank of Credits enabling credit mobility for students across HEIs, embedding cross-cutting and value-added courses across multiple programmes, extending eligibility conditions for enrolment in various programmes to graduates of vocational courses and recognizing the five-year validity of credits earned during the doctoral programme. Additionally, TERI SAS has initiated significant efforts at internationalization of the educational experience by concluding a Memorandum of Understanding with Murdoch University, Australia to facilitate collaborative research as well as student/faculty exchange.

Specifics of the implementation of various aspects of NEP 2020 as related to degree-granting programmes and their associated administrative frameworks are briefly highlighted below. (Note: R – recent implementation (within the year 2022); P – pre-existing, before NEP 2020)

- a. Registration of TERI SAS for the Academic Bank of Credits (ABC) facilitating credit accumulation and transfer has been completed. (R)
- b. Anti-discriminatory committees constituted to ensure inclusivity and equity. (P)
- c. Any member of the general public (worldwide) can register to earn credits in <u>single</u> courses independent of enrollment in degree-granting programmes, facilitating continuous, lifelong learning. (P)
- d. <u>Credit transfer</u> of mandatory course in Research and Publication Ethics for incoming doctoral students. (R)
- e. Grades in courses of the doctoral programme <u>valid for five years</u> for returning students. (R)

- f. Working professionals can enroll <u>part-time</u> for Ph.D. degrees. (P)
- g. Doctoral students acquire teaching and mentoring experience as paid teaching assistants in M.Sc. programs. (P)
- h. Inclusive and multi-disciplinary eligibility criteria for master's programmes. (P)
- i. B.Voc. added as an eligibility criterion for Master's programmes, subject to MPEC approval. (R)
- j. System of cross-programme 'open electives' finalized university-wide with provisions to update the list of open electives. (R)
- k. Cross-cutting courses such as 'Introduction to Sustainable Development' and 'Design Thinking' are/will be offered to Master's students across programmes. (R)



Research Development Cell

CONTEXT: Reference to the communication received from the UGC (letter NO.F.1-5/2021(NEP/DESK Parl, dated 14.03.2022), a Research Development Cell (RDC) was constituted at the TERI School of Advanced Studies with effect from 05 August 2022 (ref. notification NOT/R35 dated 05 August 2022). In accordance with the Guidelines for Establishment of Research and Development Cell (RDC) in HEIs published by the UGC, the Research & Development Cell at TERI SAS aims to nurture a culture of research in the School by promoting research in newly emerging and challenging areas of technology, science and humanities. The RDC at TERI SAS encourages students and faculty members to undertake research in sustainability related areas such as natural resources, energy and environment, water studies, biotechnology, business and sustainability, policy studies and legal studies.

OBJECTIVES: The overarching objectives of RDC established at TERI SAS are as follows:

- i) To create awareness, opportunities and an enabling ecosystem through the Department Research Committees for faculty members and students to actively engage into research and development.
- ii) To encourage faculty members for undertaking externally sponsored and nonsponsored research projects, consultancy projects and for engaging into doctoral research supervision.
- iii) To encourage faculty members and students to publish scholarly papers in national and international journals of repute and for scholarly outreach at conferences.
- iv) Through the Department Research Committees, to assist and encourage faculty members to undertake research activities and development projects supported by institutions such as DRDO, DBT, CSIR, DST, AICTE and UGC and for conducting capacity building activities such as seminars, workshops and Faculty Development Programs and for deriving benefits of DSIR recognition as a Scientific and Industrial Research Organization (SIRO).
- v) To encourage faculty members to organize at TERI SAS, as well as attend externally organized faculty development workshops and staff development activities assisting in promotion of research and development.
- vi) To create an enabling environment for ideas and innovation at TERI School, facilitated through the Institution's Innovation Council (IIC) and the Entrepreneurship Development Cell (EDC).
- vii) Through the Department Research Committees, to encourage faculty members, research staff, doctoral research students and master's students for actively engaging into any other research and development related activities.

The Research and Development Cell at TERI SAS shall continually work towards improving the research processes and profile of TERI SAS through guidance from the Research Advisory Committee (RAC) and assistance from committees such as the Department Research Committees, Institutional Academic Integrity Panel, Research Ethics Committee, Institutional Bio Safety Committee (IBSC) and through provision of the Intellectual Property Policy.

Consultancy Policy

1.1 Objectives

TERI School of Advanced Studies envisions a more sustainable world through the creation of knowledge and human capacity. In this regard the faculty of TERI SAS has gained expertise in important areas of sustainable development through their world class research in critical areas of knowledge. TERI SAS aims at promoting the use this expertise in augmenting its reputation by offering the services of its faculty members and researchers for collaborative research and consultancy services. It is expected that this Policy would create mutually beneficial opportunities for TERI SAS, its members of the faculty and researchers, students, various international, national, for-profit and non-profit organisations and thus contributing to the nation building.

1.2 Definitions

- **121 Consultancy Services:** This will include an assignment for providing expert advice, problem solving, targeted training such as MDPs, teaching assignments for course(s)¹, laboratory-based testing and analysis report, market research and survey in the areas of the expertise of TERI SAS faculty and researchers.
- **1.22 Consultants:** Faculty member/s and researchers of TERI SAS engaged in in Consultancy Services are hereinafter referred to as Consultant/s.
- **123 Beneficiary:** The international, national, for-profit and non-profit organisations seeking Consultancy Services are referred to as Beneficiary.
- **124 Restricted Funds:** Funds end-use of which is specified by the funding source such as donor, funding agency or client.
- **1.25** Unrestricted Funds: Funds end-use of which is not specified by the funding source.

¹ Invited talks and guest lectures will not be part of consultancy services

1.3 Conditions of Engaging in Consultancy Services on behalf of TERI SAS

- **131** Consultants shall undertake Consultancy only through a written agreement/ MoU/Sanction Letter with/from the Beneficiary. No Consultancy shall be undertaken through verbal agreements/assurances. As the reputation and goodwill of TERI SAS is involved, Consultants shall undertake Consultancy Services only in areas of their expertise.
- 132 Consultants shall not engage in any Consultancy Services that are in contravention to the laws of the land and also against the Vision and Mission of TERISAS. During no stages of the assignments, the Consultants shall engage themselves in any illegal/unethical practices including payment of bribe/corruption.
- **133** TERI SAS encourages faculty members and researchers to undertake Consultancy Services as an Individual and also as Group Consultancy, comprising of a team of Consultants across Departments/Centres. All consultancy shall be referred to as 'Institutional Consultancy'.
- 134 Consultants shall undertake Consultancy Services by submission of consultancy proposal application to the Research & Development Cell (RDC) through Head of Department/Centre, on the recommendation of Director RDC and approval of Chairman, Research Advisory Committee (RAC). The total number of days allocated for undertaking consultancy activities shall be as per the provisions given in Section 1.3.5.
- 135 TERI SAS is a University engaged in imparting education and hence Consultancy Services undertaken by Consultants shall not affect their primary responsibility towards TERI SAS/their Department and most importantly the students. The time required for successful completion of Consultancy assignments shall under no circumstances be at the cost of UGC stipulated teaching hours of a Consultant and shall not be more than 52 working days. It shall be the responsibility of the Dean (Academic) to ensure this.
- 136 Consultants may sub-contract part of the Consultancy assignments after due approval from the competent authority (Section 1.3.4) to any person or Institution outside TERI SAS for which clear terms of reference shall be defined. The Consultant shall make sure that such person/institution and their activities and deeds are in no-way in contravention of the laws of the land.
- 137 The revenue/fee accruing from the Consultancy Services shall be accepted only through the official bank accounts of TERI SAS and these revenues shall be accounted and audited in accordance with the accounting/auditing practices of TERI SAS.

138 A written contract shall be signed by Consultant(s) clearly indicating the nature and details of work expected along with completion time at the commencement of the consultancy assignment.

1.4 Revenue sharing

- **141** Ownership of Intellectual Property Rights (IPR) and allocation of revenue/benefits accruing from such Rights from the Consultancy assignments shall be governed by the IPR of TERI SAS as promulgated from time to time.
- **1.42** Where there is a contradiction between terms and conditions of Consultancy contact/MoU/Sanction letter and this Policy the former shall survive except the Conditions stated in this Policy at 1.3.
- **1.43** This Policy shall apply only to the Net-Surplus in the Consultancy revenue after all Consultancy related expenses and taxes and other charges payable to the Government have been accounted for.
- **144** Subject to 1.3.5 of this Policy, no ceiling shall be placed on the maximum income that may accrue to Consultant/s. An overhead charge @20% of the gross consultancy amount shall accrue to TERI SAS.
- 145 In case the revenue is in the form of long-term periodical accruals, the Net-Surplus shall be shared in the ratio of 60:40 in favour of the Consultant/s (60%) on the one hand and TERI SAS (40%) on the other. No overheads shall be allowed in this case. The sharing of revenue shall apply to the non-restricted budget heads only.
- **1.4.6** The Individual consultant's share as stated in 1.4.5 shall be disbursed to them after deduction of applicable taxes and the same shall be reported on all Income Tax documents. The consultant fee for project duration up to one year shall be paid after the completion of the assignment and for those beyond one year shall be based on the evaluation of the Research Development Cell.
- **1.47** The Institutional share of TERI SAS shall be further equally divided between TERI SAS on the one hand and the concerned Department/Centre/ of the concerned Consultants. This fund shall be utilised for the academic/research activities of the concerned Department/Centre.
- **1.48** Any overheads received by TERI SAS as part of restricted funds shall be equally shared between TERI SAS and the Department/Centre of affiliation of the Consultant/s.

149 The institutional share of TERI SAS (less the Departmental share) shall be equally distributed between the general expense account of TERI SAS and purchase of irrevocable Government Securities thereby adding to the Corpus funds of TERI SAS in a sustained manner.

1.5 Dispute Resolution and Jurisdiction of the Court

- **151** Any dispute regarding the implementation of this Policy shall be resolved internally by a Committee consisting the Vice Chancellor, the Registrar, Dean (A), Dean (R&P) and the Finance Officer.
