Dr. Manipadma Datta, Pro Vice Chancellor have informed to the members that since pandemic situation the University is not working to its full capacity due to non-operation of different revenue verticals like research activities, workshop & seminars, MDP's and hostel fees consequently, the inconsistent cash inflows impacting the committed payments, statutory payments (Income Tax and Provident Fund) and salaries.
