#### Minutes of the Board of Studies Meeting

A meeting of the Board of Studies (BoS) of the Department of Policy Studies (DoPS) was conducted online on 11 August 2021 during 2:00 - 3:30 PM.

#### Agenda

- a) Confirmation of minutes of the last BoS meeting held on 9 December 2020.
- b) Review of the course outlines of the Masters and Doctoral Programme of the Department in the wake of the course credit revision and minor modifications to comply with the UGC guidelines on credit hours. (Refer annexure 1)
- Approval for the change in the Programme Outline of MA in Public Policy & Sustainable Development (PPSD) due to the withdrawal of two old courses and the introduction of two new courses (Refer annexure 2)
- d) Presentation of the Structured Feedback (Phase-1) Report of MA-SDP Programme

The BoS Chairperson welcomed the BoS members, and the BoS Secretary briefed the agenda items and requested the respective Programme Coordinators to present their points during the meeting under the concerned agenda items. BoS Secretary moderated the meeting. The sequence of events, presentation, discussion, comments, suggestions, and resolutions are summarized below under the respective agenda:

#### Agenda 1:

The Board confirmed the minutes of the last meeting held on 9 December 2020.

#### Agenda 2:

Dr. Kavita Sardana, Program Coordinator, MSc (Economics), presented the revised course outlines of the courses offered in the MSc. (Economics) programme with the rationale for the course credit alignment. This followed the discussion:

- a) Prof. Avanish said that this was entirely a faculty-driven modification and such modifications hardly contributed a ten percent change in the overall course outline, so he believed that such changes from the faculty members should be respected, and he was okay with the proposed changes. However, the programme coordinator can assess the overall changes in the programme in terms of lecture/practical hours in the wake of such increases in the specific courses, and this should be entirely for their assessment, not for the BoS members.
- b) Dr. Nandan Nawn highlighted that the course "PPE185: Environment and Economic Development" has also proposed changes in the evaluation criteria, where the number of written exams is proposed to be reduced from 3 to 2. Now, the total number of assessments shall be 3 with a higher weight to the literature survey.

Dr. Swarup Dutta, Program Coordinator, MA (SDP), presented the revised course outlines of the courses offered in the MA (SDP) programme with the rationale for the course credit alignment. This followed the discussion:

- a) Prof. Meeta Mehra just enquired about the changes in most courses, and she was informed about the same accordingly by the Programme Coordinator.
- b) Prof. Avanish pointed out that there was a need for minor editing in the remarks in the case of a few courses.
- c) Dr. Swarup Dutta acknowledged the comments and ensured to revise the text at specific places accordingly.

Dr. Chandan Kumar, Program Coordinator, MA (PPSD), presented the revised course outlines of the courses offered in the MA (PPSD) programme with the rationale for the course credit alignment. He also highlighted that the course "PPS 127: Sustainable Consumption and Production" includes minor modifications in the evaluation pattern. This followed the discussion:

- a) Prof. Avanish Kumar acknowledged his concurrence with the underlying changes in the programme outline. In addition, he also suggested that the programme may include a few new courses covering the impact of COVID-19 on several socioeconomic aspects, governance, and the policy in the post-COVID scenario in the future, as the plethora of literature has been piled up in this domain.
- b) Prof. Meeta Mehra pointed out that she did not find any specific course covering the 'Education Policy' domain, which was earlier part of one of the programme's withdrawn courses (PPS 192). However, she highlighted that in the backdrop of the New Education Policy, the discourse on education has also gained attention in present times.
- c) Dr. Laksh clarified that the education policy discourse had not been compromised. He further added, "The scope for education-specific discourse is already there in the existing courses, such as "PPS113: Society and development policy" and "PPS194: Public policy processes and institutions", where through seminars and group presentations, those issues will be adjusted, and that is why we did not introduce any specific course on education."

Dr. Chandan Kumar presented the revised course outlines of the courses offered in the coursework of the Ph.D. programme with the rationale for the course credit alignment. This followed the discussion:

- a) Prof. Avanish Kumar suggested that Research and Publication Ethics (RPE) may be revised to focus more on the practical component. The members agreed with the suggestion, and it was decided that revision of the course structure of RPE can be taken up in AY 2022-23.
- b) Prof. Meeta Mehra and Dr. Nandan Nawn suggested that a seminar course reflecting policy level issues may be offered as an elective at the Department of Policy Studies for the Ph.D. programme.

#### Resolution:

The BoS members approved the revised course credit alignment and other ancillary modifications in the course outlines of all the courses of the Masters and the Ph.D. Programmes presented before them and as summarized in the enclosed summary sheet of the course credit revision.

#### Agenda 3:

Dr. Chandan Kumar, Program Coordinator, MA (PPSD), presented the revised programme outline of the MA/PG Diploma in PPSD programme. This followed the discussion:

- a) Prof. Avanish and Prof. Meeta both acknowledged their approval for the revised programme outline.
- b) Prof. Avanish also recognized the fact that now as per the instructions of the Department of Personnel & Training (DoPT), only ten percent of lectures/classes are suggested to be attended by the students physically, as the DoPT informed that the majority of the classes for such programmes are advised to be conducted online. The iGOT (Integrated Government Online Training) Policy of DoPT has a very precise explanation in this regard, which could be referred.

#### Resolution:

The revised programme outline of the MA/PG Diploma in PPSD programme was approved by the BoS to be presented before the Academic Council for further approval.

#### Agenda 4:

Dr. Swarup Dutta, Program Coordinator, MA (SDP), presented the Phase-I report on the structured feedback received from the key stakeholders, including alumni, students, and employers on the MA (SDP) programme restructuring. This followed the discussion:

- a) Prof. Avanish initiated by enquiring about the sample characteristics of the stakeholders who provided the feedback and suggested to draw inferences from the gathered feedbacks very cautiously. He suggested identifying the convergence point in the received responses across the stakeholders, as the present feedback cannot guide any specific direction to move ahead. These feedbacks require much churning among the internal faculty members of the programme to extract any logical way forward. He said there were mainly three takeaways he could draw from the presentation:
  - Changes in the domain knowledge which needs to be scrutinized by the internal faculty members – what to include and what to exclude – based on the discussion taking the programme in entirety and considering the central idea of the global MDP curriculum.
  - ii. Focus on skills and their application, and
  - iii. Pedagogy related issues

According to Prof. Avanish, the members of the programme restructuring team should also focus on the relevance of this feedback in consultation with the domain experts and the senior academicians from a similar academic programme.

- b) Prof. Meeta Mehra also pointed out similar issues, acknowledging her agreement with Prof. Avanish. She reiterated the need for reaching a convergent opinion as the feedbacks, which was based on a small sample size and might be of a widely divergent group, cannot be reliable enough to make any conclusion. However, the demand for skillsets both for quantitative and qualitative methods gives a clear direction to employability aspects. The team has to inspect to what extent such methods are already imbibed into the curriculum and how much scope to ingrain more.
- c) Dr. Swarup sounded in consonance with both Prof. Avanish and Prof. Meeta and informed the members that the feedbacks of Phase-I would be scrutinized further. A detailed review of the programme and required modifications at the course level will be carried out by the internal faculty members in the next phase, including the suggestions from the domain experts and the peer academicians from other universities.

- d) Dr. Gopal Sarangi further clarified that the whole idea of surveying a few key stakeholders was to understand whether there was a need for programme restructuring or not, and it is clear from the responses that there is a need to review the programme structure. Second, in response to the issues raised by Prof. Avanish related to the challenge before the programme which course/domain of knowledge to include or exclude in the curriculum, he said a middle way could be adopted, and these domains could be included in the existing courses itself to some extent. However, he agreed with both Prof. Avanish and Prof. Meeta that this exercise has to be scrutinized in the next phase, where a more detailed survey needs to be carried out, and the feedback of other important stakeholders such as peer academicians and the domain experts from other educational institutions has to be included.
- e) Dr. Shantanu De Roy further sounded in support of the earlier discussions. However, he highlighted the issues that the programme restructuring team also need to focus on the central nature and objective of the programme, as it caters to the candidates coming from an interdisciplinary background, so flowing with the opinion of a few students who seem to be in favour of introducing more skills-based courses, mainly quantitative methods, might not be justifiable. So, the core team has to keep all these aspects under consideration.
- f) Dr. Smriti Das reiterated the point that these feedbacks from a few stakeholders were just a starting point to understand the opinions on the need for change in the programme. She acknowledged that the feedbacks were very broad at this point, and that did not give any direction, as many of the alumni who participated in the feedback survey were placed at diverse places and they sounded their opinion. However, moving ahead, there are 2-3 more stages where these issues would be refined. The programme is now planning to take feedbacks on each of the ongoing courses, and discuss them internally in the core faculty team before organizing a workshop inviting other stakeholders to discuss the current scenario in the development sector. Over the period, the programme has had also an accumulated feedback on each of the offered courses, which will also be factored in while finalizing the nature and extent of change required in the programme.
- g) Dr. Swarup finally responded that in the next phase, a workshop would be conducted including all key stakeholders, and a detailed discussion will be done where all the issues raised and suggested by the BoS members will be taken into consideration.

#### Resolution:

The comments suggested by the BoS members will be taken into consideration by the Programme Coordinator and the review team members in the next phase of the review, and the findings will be presented in the next BoS meeting.

The BoS Chairperson concluded the meeting with a vote of thanks.
