The course examines various aspects of international environmental law including the link between environment and development, the law pertaining to international organizations, transboundary pollution, the global commons and the protection of species.

Environmental Law – Subject taught in the academic year 2017-18

The course explores various aspects of domestic (Indian) environmental law including common law remedies, constitutional provisions and the examination of statutes like the Environmental Protection Act, Water (Prevention and Control of Pollution) Act and the Air (Prevention and Control of Pollution)

Food Law - Subject taught in the academic year 2017-18

The course examines the fundamental concept of the right to food. It also explores themes such as institutions and rules governing food law, the standards that apply to the Public Distribution system, the interactions between international organizations and domestic governments, and how the government ensures the three basic concepts of adequacy, availability and accessibility and prevents starvation, famine and provides employment and women empowerment.

Property Law – Subject taught in the Academic year 2017-18 and 2018-19

The course explores the fundamentals of Indian property law and the structural arrangements of the transfer of property in India. It also examines statutes such as the Transfer of Property Act, and the Indian Easement Act.

The Law of Contract (II) - Subject taught in the Academic year 2017-18

The course is designed as an advanced course pertaining to the law of contracts. It explores concepts such as indemnity, guarantee, bailment, pledge, agency and partnership.

Tutorials examined fundamental legal issues associated with commercial transactions including introductions to the nature and role of commercial law before addressing the sale of goods (with emphasis on the Sale of Goods Act 1979), and other aspects of the sale of goods, such as agency and security. Tutorials looked at domestic business to business transactions as well as the influence of the EU regulations. My duties included preparing and delivering tutorials, student liaison and marking formatives. I also provided feedback on the end of year exam questions.

EU Law – Taught three tutorial groups for the academic year 2013-14.

Tutorials examined various aspects of EU law including, the EU's constitutional and institutional structure, the principal sources and development of EU law, its relationship to the national legal order in the United Kingdom and the resolution of conflicts between national law and EU law, the enforcement of EU law by the CJEU and national courts, and the free movement of goods and services. My duties included preparing and delivering tutorials, student liaison, group work assessment and marking formatives.

WTO Law - Conducted two seminars for the academic year 2013-14 and one seminar for 2012-13.

The seminars were titled 'The WTO and Environmental Issues' and 'The WTO and Bilateral and Plurilateral Trade Agreements'.

'The WTO and Environmental Issues' seminar looked at the various WTO provisions concerning environmental regulations and standards in the GATT, GATS, SPS and TBT Agreements. It discussed the developed and developing country friction that affect the proper formation and implementation of international environmental policies and standards in WTO and international trade in general, including the issues of Processes and Production Methods (PPMs) and extraterritoriality.

'The WTO and Bilateral and Plurilateral Trade Agreements' seminar looked at the WTO compatibility and the interrelationship between bilateral and plurilateral agreements including WTO-plus agreements. Topics of discussion included the MFN exceptions and the 'Enabling clause' as well as a look into Investor-State Dispute Settlement Clauses. My duties included preparing and delivering the seminars and seminar sheets. I also drafted summative and 'resit' questions for the WTO module.

The thesis discusses environmental standards within international trade in goods. It compares the unilateral imposition of standards by nation states and their potential to be perceived as technical barriers to trade. The research compares unilateral standards (and the corresponding developed and developing country friction) with the increase of standards through transnational governance, especially through mutual recognition agreements, and agreements with elements of mutual recognition. Considering the international trade-environment paradigm, the thesis simultaneously considers the WTO compatibility of environmental standards, national unilateral instruments and mutual recognition agreements. This also necessitates research into the commercial and environmental priorities of national policy and national regulations.
