Dissertation Title: Augmenting employees' efforts in innovation

It has been found in the literature that more stringent the labour laws of the country, more innovations will take place in that economy. The most common law talked about is Wrongful Discharge Laws (WDL). Apart from this, in various economies nuisance suits take place.. Usually the result of these suits is that both parties settle with each other. This dissertation is an attempt to relate both WDL and nuisance suits with the employee's efforts in innovations. In this respect, a game-theoretic model is developed enlightening the equilibrium level of employees' efforts in the presence of nuisance suits, where there is a possibility of employees getting discharged from firm. It is found that with the possibility of nuisance suits in the economy, stringency of WDL has no impact on employees' efforts if defence cost of firm is low but for higher defence costs, WDL affect employees' efforts. Also the efforts exerted by employee in the innovative project are found to be weekly increasing in the defense costs of firm. Apart from this, timing of innovation is also examined for both employees and employers in the presence of competition. It is found that a contract containing benefits for winning competition and punishment for failure of innovation reduces the chances of contradiction between employee and firm.
